I am retired from 32 years of Federal Service. I have been a licensed CPA since 1983. I served as internal and external auditor with the Department of Interior's Office of the Secretary. In this position, I performed internal audits of Federal agencies and external audits of Government contractors. I also worked as a management and program analyst, budget officer, contract administrator and payroll system administrator. I have over 25 years experience in incident management of large disasters.

9. Briefly explain how your education and/or previous career experiences will be beneficial to you as a member of the Board of Directors.

I identified fraud, waste, and abuse in Federal programs. As a management and program analyst, I identified problems and conditions which required attention. I developed policies and procedures to resolve issues, made and implemented recommendations, and improved program effectiveness in a cost effective and efficient manner. I negotiated and administered Federal contracts. I have a strong background in procurement, budget development and administration, and information technology systems.

I am married to wife Jeanne (a retired high school teacher) and I am the father of 2 daughters. We enjoy taking our Golden Retriever (Kona) for daily walks in Green Valley.
