Performance of Assets in Funds

IRF: the assets remaining in the fund are performing at negative 1.2% since acquisition.

MRR: the assets remaining in the fund are performing at 12.7% since acquisition.

MRR-B: the assets remaining in the fund are performing at 5.4% since acquisition.

ERF: the assets remaining in the fund are performing at 37.7% since acquisition.

All funds: the totals of assets remaining in all funds are performing at 11.6% since acquisition.

Cash Holdings within Funds

IRF: the cash balance is at \$164,907 or 12.9%, above the Range of the IPS.

MRR: the cash balance is at \$213,153, or 2.6%, within the Range of the IPS.

MRR-B: the cash balance at \$60,242, or 5.3%, within the Range of the IPS

ERF: the cash balance is at \$20,753 or 3.5%, within the Range of the IPS.

Total cash in the SBH funds is at \$459,054 or 4.1%

IPS Targets and Ranges: 30% Cash 70% Fixed Income; within IPS ranges

Performance: effectively breakeven

Cash Holdings: \$3,150,198 is above IPS range

JPM Long-Term Operating Cash Fund

IPS Targets and Ranges: At 2.3% Cash; 27.2% Fixed Income; 70.5% Equities; all within IPS ranges

Performance: 0.80% loss since inception

Cash Holdings: at \$41,697, or 2.3%, within IPS Range
