- Tenant cards are issued up to 1 year at a time.
- Tenant card renewals require a new Tenant Card Request Form.**
- GVR # referenced above is the number printed on owner's card(s).
- Tenant Card Request Form must be completed and signed by the owner or Property Company. **Lease agreements will not be accepted.**
- Tenants who have guests may purchase guest cards for \$10.00 a day for unlimited guests.**
- Guest card fees are non-refundable.
- If property owners' account becomes delinquent at any time, the account will be frozen and all membership privileges will be denied.
- The property owners' membership will be suspended during the above noted time of tenancy.
- It is the property owner's responsibility to be aware of current GVR policy regarding the issuance of Tenant cards.
